The referees officiating at EFC U17 Circuit should have DFB CN licence and an annual licence, good national or international level qualification and be aged minimum 18 and less than 60.

The German Fencing Federation will provide the necessary referees for the German clubs.

A referee fee of EUR 40.00 must be paid for each German participant. The fee is to be transferred

to the DFB with the entry confirmation.

Image / TV rights The participants and their legal representatives declare that they agree to a publication of their

names, clubs and year of birth as the as the competition data.. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but











in particular the right to reproduce recordings in print, TV shows and the Internet. There is the

possibility, but no obligation, to give the name.

**Medical** A doctor is present in the competition site.

Only doctors are entitled according to the international statutes to grant medical breaks during the

fights.

All participants are required to check prior to the event to see if any more extensive EFC or state

regulations have not been implemented.
